The holiday spirit is all about giving. But what does one give the man or woman who has it all?

Every year, this question vexes eager-to-please shoppers, who engage in a veritable hunt for the perfect gift. Another boring necktie, Rolex or ring simply won't do. It's got to be unique. It's got to be special. And it's got to be spectacular.

Rather than guessing what your certain someone desires, instead, go straight for the "wow" factor.

Consider, for instance, Nieman Marcus' annual Christmas Book, which always includes a selection of extravagant "fantasy gifts" for the hard-to-please. Last year's 100th Anniversary Edition included a "Classical Superstars Fantasy Concert" hosted by Regis Philbin for \$1.59 million, a diamond-studded cell phone for \$73,000, a submarine for \$1.44 million, and a 100-foot dragon topiary with golden claws, teeth, horns and fins for \$35,000.

Although yard art and classical music aren't for everyone, the following gift ideas are sure to impress most anyone on your list.

1. A Trip to Outer Space

When you're shopping for someone you love, you should shoot for the moon. And thanks to Virgin Galactic, you can-literally. That's because Sir Richard Branson's space tourism venture, which debuted in 2004, plans to offer its suborbital spaceflights to the general public for an initial downpayment of \$20,000 and an eventual price tag of just \$200,000. The once-weekly flights will take off from the Mojave Desert in California and will last approximately 2-1/2 hours, during which time six passengers and two pilots will climb to a height of about 360,000 feet (roughly 68 miles) and experience up to six minutes of weightlessness before returning to Earth.

If you know a car enthusiast, check out Fort Worth, Texas-based Texas Driving Experience, which offers a three-day, four-night "Be a Race Car Driver" camp. For between \$30,000 and \$150,000 per person, you'll drive on three separate tracks at the Texas Motor Speedway, the second-largest sporting venue in the United States. You'll be trained by professional drivers, drive NASCARs and race-prepared Corvettes, and housed at the Penthouse Condos, overlooking the speedway.
